By signing this form, I (hereafter called the "Cardholder") register for Banyan Privilege Club Value Card (the "Value Card") issued by Banyan Thailand, Hua Hin ("Banyan") and agree to the following terms and conditions:

1. To activate and receive the Value Card, the Cardholder agrees to pay a minimum of THB 7,000 as an initial amount, whereas THB 2,000 of such initial amount will be kept as a deposit and cannot be used. Any amount other than such THB 2,000 deposit shall be usable and regarded as cash balance.

However, such THB 2,000 deposit shall be refunded to the Cardholder after the Value Card is terminated in accordance with Clause 11 or is revoked by Banyan in accordance with Clause 12.

2. The Value Card is valid until 31 December 2021 starting from the execution date as stated herein below. Any issue of new 1-year Value Card will be subject to sole discretion of Banyan.

3. The Value Card is the sole property of Banyan, non-transferable and shall be used by the Cardholder or his/her spouse only.

4. Subject to Clause 1. above, the Cardholder can use the cash balance of the Value Card at Banyan Golf Club by presenting the Value Card at its point of sales.

5. The Cardholder can enjoy the following benefits at Banyan Golf Club:  
(1) 20% discount on green fees, either weekday or weekend rate;  
(2) 10% discount on food and beverages;  
(3) 10% discount at Pro Shop; and  
(4) discounted entry fees to Banyan Privilege Club events.

6. The Cardholder can enjoy privileges programs (discounts and/or special offers) from Banyan's partners.

7. Such privileges programs as stated in Clause 6. above shall be depended on Banyan and/or each partner's policy.

8. The Cardholder cannot enjoy benefits and/or privileges programs as stated in Clause 6. and 7. in conjunction with other privileges, promotions, discounts or vouchers in process.

9. In no event will Banyan be liable for any damages, including without limitation direct or indirect, special, incidental, or consequential damages, losses or expenses arising in connection with privileges programs and/or terms and conditions thereof, even if Banyan is advised of the possibility of such damages, losses or expenses.

10. In the event that the Value Card is lost or substantially damaged, the Cardholder shall inform Banyan in writing in order for Banyan to issue a new Value Card with THB 500 charge to the Cardholder.

11. The Cardholder may terminate the Value Card at any time by providing Banyan written notice to email address: sales@banyanthailand.com or to the address: 68/35 Moo ban Hua Na, Nong Gae Subdistrict, Hua Hin District, Prachuabkirikhan Province, 77110, Thailand. Any remaining cash balance of the Value Card, after deduction of any transfer fees, will be refunded to the Cardholder within 14 days with no interest.

12. Banyan can revoke the Value Card with no cause by sending 14 days prior written notice to the Card Holder by email and will return any remaining cash balance together with THB 2,000 deposit as mentioned in Clause 1. to the Cardholder with no interest within 14 days after sending the revoking email.

13. Banyan is entitled to remove, revise, add and/or modify any terms and conditions herein or any terms and conditions of any privilege programs at its sole discretion without any notice.

14. Other additional terms and conditions which may apply to any terms and conditions aforementioned herein will be subject to sole discretion of Banyan.
